RONALD E. BARTHOLOMEW teaches full time at Brigham Young University, USA, in the Department of Ancient Scripture. His research interests include Church History and Missiology in the non-industrial counties of England in the 19th Century. He has also written and published on various topics relative to the history of the LDS Church and the LDS Scriptural Canon. He is married to the former Kristen Buckwalter and they are the parents of seven children, ages 7–23.

SAMUEL BROWN is Assistant Professor of Pulmonary and Critical Care Medicine at the University of Utah (commencing July 2009). His primary research is in the epidemiology of life-threatening infection and also writes cultural and religious history, focusing on beliefs about sickness, death, and afterlife. He is currently completing a book-length history of early Mormon death culture called *In Heaven as it Is on Earth: Joseph Smith and the Conquest of Death*, which expands many of the ideas described in this commentary.

DOUGLAS J. DAVIES, is Professor in the Study of Religion at the Department of Theology & Religion, Durham University, UK. and Director of that University's Centre for Death and Life Studies. Previously he was Professor of Religious Studies at Nottingham University whose Ph.D. he holds for a thesis on salvation in relation to the sociology of knowledge. He was born and educated in South Wales, and at Durham University's Departments of Anthropology and of Theology, and at the Institute of Social Anthropology at Oxford University whose M.Litt., and D. Litt. Degrees he holds. In 1998 the University of Uppsala conferred the honorary degree of Doctor of Theology upon him. He has been a visiting research fellow at Oxford's Rothermere American Institute, at the Huntington Library in California as well as at Brigham Young University. He sits on the editorial boards of *Mortality* (UK) and *Thanatological Studies* (Italy). He has taught course on death, ritual and belief for many years both at Nottingham and Durham Universities. He is also well-known for his research on Mormonism,

Anglicanism and theoretical aspects of the anthropology and theology of religion.

JOHNNIE GLAD has studied at the University of Oslo, Det teologiske Menighetsfakultet (MF Norwegian School of Theology), Oslo, Columbia University, New York, Union Theological Seminary, New York, and Boston University – School of Theology. He is a member of the clergy roster of The Evangelical Lutheran Church in America. Dr. Glad served parishes in New York, New Jersey, Wisconsin and Massachusetts. After returning to Norway in 1968 he taught religion at Levanger Teachers' College, Levanger, and later at what is now the University of Stavanger, Stavanger. He is now Professor Emeritus but is engaged fulltime in his research work. He holds master's degrees in Theology and Religious Education and a doctorate in Theology. Dr. Glad's doctoral dissertation *The Mission of Mormonism in Norway 1851–1920. A Study and Analysis of the Reception Process* has been published by Peter Lang (Frankfurt am Main, 2006).

RONAN JAMES HEAD teaches religion and philosophy at Loughborough ("Luffborough") Grammar, a private boys' school in the English Midlands. He is also completing a PhD in Near Eastern and Biblical Studies at the Johns Hopkins University. Ronan was a Nibley Fellow with the *Foundation for Ancient History and Mormon Studies* in 2000–2005; writes for the Mormon blog, *By Common Consent*; and has recently been appointed as the international editor of *Dialogue: a Journal of Mormon Thought*. He is one of the founders of the *European Mormon Studies Association*.

MASSIMO INTROVIGNE was born in Rome, Italy, on June 14, 1955. He received a B.A. in Philosophy at the Gregorian University in Rome and a Dr. Jur. at University of Turin's Law School with a dissertation on John Rawls. He has taught sociology of law and sociology of religion as a part time lecturer, inter alia, at the Pontifical University of the Holy Cross and the European University in Rome. He is managing director

of CESNUR, the *Center for Studies on New Religions*, in Torino, Italy, and the author of some 40 books in Italian (some of them translated into French, Spanish, Czech, Croatian, and English) and of more than 100 articles in peer-reviewed journals in the field of sociology of religion and religious studies, including *Brigham Young University Studies*, the *Journal of Book of Mormon Studies* and *Dialogue: A Journal of Mormon Thought*.

DAVID M. MORRIS is an historian and doctoral candidate at University of Chichester, England, analysing the relationship between class and religion in Victorian Britain by means of a case study on British Mormonism. As well as being the author and maintainer of www.mormonhistory.org, he is currently working on several books including the *History of the Latter-day Saints' Millennial Star 1840–1900*; a 2-volume series *History of the Church in the British Isles* (vol. 1 1837–1899) and (vol. 2 1900–1999). He is also preparing a multi-volume comprehensive series *Mormonism in Europe* with Kim Östman. He is one of the founders of the *European Mormon Studies Association* and general editor of the *International Journal of Mormon Studies* (IJMS).

REID L. NEILSON completed his Ph.D. in religious studies (American religious history emphasis) in 2006 at the University of North Carolina at Chapel Hill, USA, where he was named an International Studies Scholar for Tomorrow Fellow and was the recipient of several grants and an award. Dr. Neilson is the author of two family biographies and the editor or co-editor of 11 academic books, including *Joseph Smith: Reappraisals after Two Centuries* (Oxford University Press), *The Rise of Mormonism* (Columbia University Press), *The Mormon History Association's Tanner Lectures: The First Twenty Years* (University of Illinois Press), *Believing History: Latter-day Saint Essays* (Columbia University Press), and *Taking the Gospel to the Japanese* (Brigham Young University Press).

KIM B. ÖSTMAN is a doctoral candidate of comparative religion at Åbo Akademi University, Finland, compiling a dissertation titled *The Introduction of Mormonism to Finnish Society, 1840–1903*. He works as a researcher of radio-frequency microelectronics at Tampere University of Technology, Finland. Östman has published scholarly articles on Mormonism in the journals *Uskonnontutkija – Religionsforskare*, *Siirtolaisuus – Migration*, *Finnish Journal of Theology*, *Journal of Mormon History* and *Dialogue: Journal of Mormon Thought*. He is one of the founders of the *European Mormon Studies Association*.

HEIKKI RÄISÄNEN earned M.Th., Lic.Th., M.A. and Th.D. degrees at the University of Helsinki, Finland, in 1965, 1967, 1968 and 1969, respectively. From 1969 to 1974, he was a Docent of New Testament Exegesis at University of Helsinki, where he worked from 1975 as a Full Professor of New Testament Exegesis until 2006. During that time, he was appointed Research Professor by the Academy of Finland (1984–1994), was Head of a Centre of Excellence in the Department of Biblical Studies at the University of Helsinki (1994–2005), and an Academy Professor of the Academy of Finland (2001–2006).

G. ST. JOHN STOTT (GRAHAM) has a Ph.D. in English and American Literature from Brigham Young University, and has taught in Tunisia, Palestine and the Gulf. He is currently Associate Professor of English at Arab American University, Jenin. His interest in the Book of Mormon goes back over forty years, and he has published on it in a range of journals.

GRANT UNDERWOOD is a professor of history at Brigham Young University, USA. He has written or edited a number of books and articles on Mormon history, including the prize-winning *Millenarian World of Early Mormonism* and two volumes on LDS history in the Pacific. At present, he is the lead editor of the first two volumes in the *Documents Series in the new Joseph Smith Papers* project. He also serves as co-chair of

the Mormon Studies Consultation in the American Academy of Religion.

JORDAN WATKINS obtained a B.A. in History, with an emphasis on U.S. religious history. Following graduation in April 2006, Jordan worked for the Media Division of the LDS Church's Missionary Department where he organized historical information about the church's use of media, which included interviewing producers, directors, and managers. In 2007 he undertook an M.A. in History at Claremont Graduate School, USA. His thesis expands the topic of nineteenth-century transcontinental travel writers and he will shortly commence a Ph.D. program in history at the University of Nevada, Las Vegas.

FRED E. WOODS holds the Richard L. Evans Chair of Religious Understanding at Brigham Young University, USA, where he is a professor of Church History and Doctrine. He is the editor and compiler of the "*Mormon Immigration Index CD-ROM*" and has authored or co-authored six books and many articles in over a dozen different periodicals both nationally and internationally.
